Section 1 Horizontal Filtering Toolbar and Export Function

If logged in to the SSO or “_acct” level, the **Authentication** section of Historical Analytics will display default results for **Merchant ID: All**, **Date Range: Last 7 Days**, and **Reporting As: USD**. Variations on these dimensions may be selected. An additional applied filter for **Count/Amount: Count** is located below, plus a drop-down menu to select additional dimensions to further explore. The example below shows an applied filter for **Billing Country: Canada**, with the drop-down menu revealing more filters that could be applied to **Authentication** results.

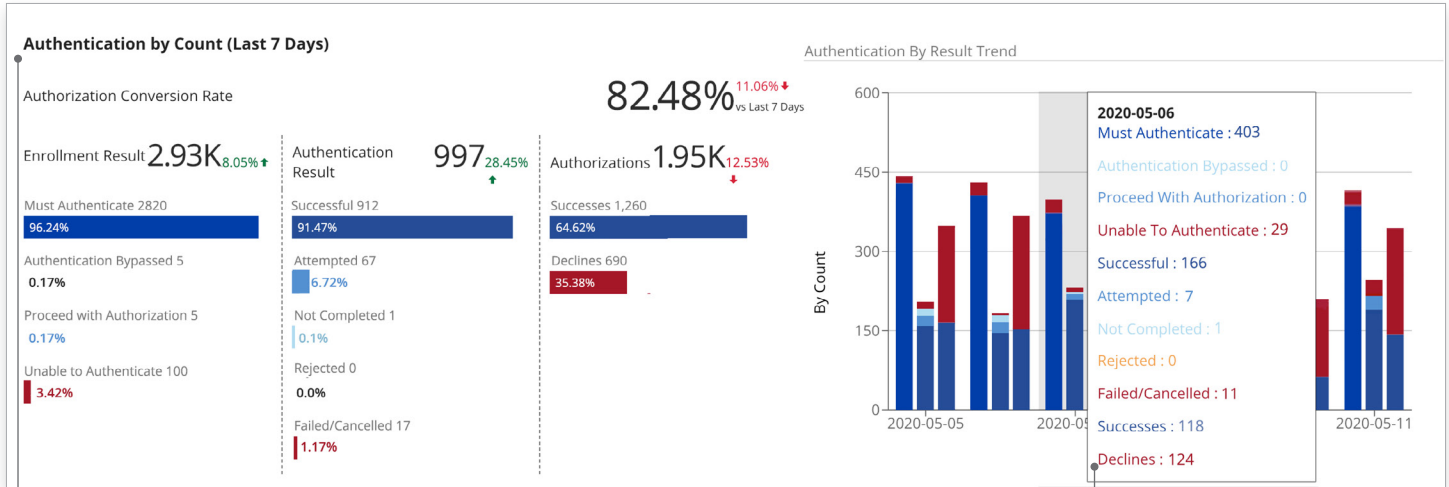

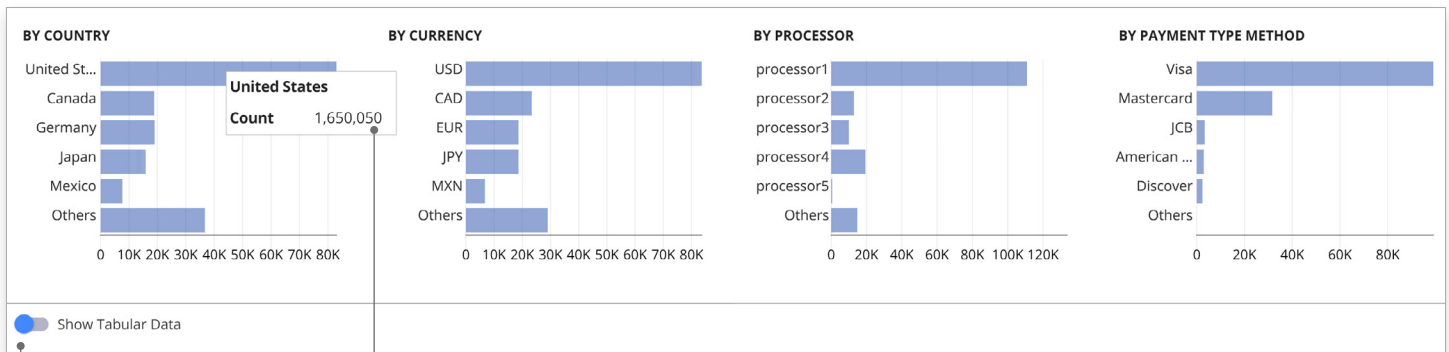

The header area scrolls horizontally to reveal more dimensions.
